The original applicant for site 7 did not respond in writing to the letter delivered to him on 14 December 2016, seeking clarification of the ownership of this site. The original applicant did however phone the Chairman of the Steering Group on 19 December 2016. A follow-up letter was hand-delivered to the original applicant on 21 December 2016. A response is awaited.

In response to the draft NP, architects acting for a landowner of a green field site at Sutton contacted the Chairman of the Steering Group seeking a meeting to present a proposal for a development of 17 houses, including a substantial proportion of affordable housing. TL and PD met the architect who was advised that the proposal fell significantly short of that offered on the preferred site and its community benefits, as set out in the draft NP. The architects will report back to the landowner.

An article has been included in the January village newsletter providing further information on the neighbourhood planning process and informing readers of the extension of the consultation period.

As of 5 January 2017, nineteen written comments had been received on the draft NP and Steering Group members have continued to receive many verbal comments. Steering Group members will encourage parishioners to submit written comments before the closing date, 16 January 2017. **All to action**
